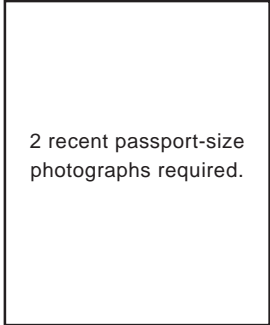

A warm welcome for joining our Aikido class! We like to explain to you our TERMS & CONDITIONS. Please read this carefully:

1. Aikido Shinju-kai is the organisation that conducts your Aikido lessons. Your current training place will be your Principal-Dojo. All Principal-Dojo training fees must be paid before the start of a new term.
2. All students MUST sign the Deed of Waiver and Indemnity and return the form to your Instructor/Leaders immediately. No students are allowed to train without signing the form.
3. All students must be member of Aikido Shinju-kai. Members will receive a membership booklet for recording their grades, seminars and other details.
4. An application fee of S\$25 will include an Aikido Shinju-kai student's handbook. Annual membership fee and subsequent renewal will be S\$24 however first time applicant's membership fee will be pro-rated.
5. Any member who leaves Aikido Shinju-kai for more than 2 calender years will have to re-apply as a member. Membership fee must be renewed yearly before 31st December. A levy of S\$6 will apply if renewal is made after 31st January.
6. All payments must be made upon application prior to approval.
7. The age for children class is 5 to 12 years old. Children less than 6 years of age will not be eligible for grading.
8. Membership is strictly not transferable nor refundable in the event of termination / revocation.
9. Aikido Shinju-kai may revise the above terms & conditions from time to time without prior notice.
